CTP N.V. ("**CTP**") proposes to amend its articles of association in accordance with the draft articles of association included in this triptych. The proposals are also explained in the agenda and explanatory notes thereto relating to the annual general meeting of CTP, to be held on Tuesday 25 April 2023.

The first column sets out the current text of the articles of association. The second column contains the proposed amendments, indicated in <u>blue</u> text (added text) and <u>red</u> text (deleted text). The third column provides an explanation to the proposed amendments. Definitions used in this triptych have the meaning as set out in the CTP's articles of association.
